

WHAT WOULD YOU DO IF YOUR RELATIVE, CO-WORKER, OR FRIEND HAD A HEART CONDITION AND COULDN'T GET THE NEEDED PACEMAKER?

Cuba's exemplary healthcare system - free to all its citizens and many others through its international missions - now can't access many medicines and supplies essential for Cuban patients.

The criminal U.S. blockade on Cuba and Cuba's unjust inclusion on the "State Sponsors of Terrorism" (SSOT) list is preventing the country from purchasing pacemakers - lifesaving medical devices which maintain normal heart rate and rhythm for people with heart disease. Cuba urgently needs 2,000 pacemakers to treat its heart patients.

The situation calls for our immediate and collective action.



WE HAVE REACHED OUR INITIAL GOAL OF \$150,000, AND 130 PACEMAKERS ARE ALREADY BEATING IN CUBAN HEARTS. THANKS TO YOU AND CUBAN DOCTORS IT WAS FREE OF COST FOR PATIENTS!

So far 130 pacemakers have arrived in Cuba and are implanted in patients, and 100 more pacemakers are now on their way to Havana. The campaign is picking up momentum and support, with \$150,000 raised in North America and \$75,000 in Europe, we're sure to exceed our original goal of 300 devices.




Cuba's outstanding healthcare system has been under attack by U.S. policy.
